



About the Program

Menzies Institute of Technology has successfully taught over 4,000 International Nursing Students in Australia since 2014.

We offer an intensive 10 weeks program that assists Internationally qualified nurses and midwives (IQNMs) which includes:

- 1. 4 weeks online theoretical course for Stage 1 Multiple Choice questions (MCQ) exam
- 2. 4 weeks face-to-face practical course conducted in Melbourne, Australia for **Stage 2 - Objective Structured Clinical Examination (OSCE) exam**
- 3. 2 weeks internship at an Australian Health Care Facility after successfully passing Stage 1 and 2 and obtaining Registered Nurse registration with Nursing and Midwifery Board of Australia (NMBA)

Key Objectives

- Enable IQNMs to be adequately prepared for successfully completion of the Outcome Based Assessment (OBA) for registration in Australia
- Enable IQNMs to attend supervised and supported practical course in Australia at Menzies Healthcare Simulation Centre to prepare for OSCE assessment
- Enable newly Registered Nurses to kick start career in Australia by providing supervised and supported internship at an Australian Health Care Facility

STAGES OF REGISTRATION PROCESS AND PROGRAM STRUCTURE

Step 1

Apply for Online Self Check for IQNMs to NMBA

This Online Self-Check does not incur any fees.
Once you successfully complete the Online Self-check, then you would pay non-refundable fee of AUD 640*. This fee is used by NMBA to check IQNMs documentation and administration.



Step 2

Enroll for Menzies OBA Preparation Program

Complete an Application Form and pay the initial deposit fee.

Once enrolment is confirmed, then you will receive access to Menzies Institute online learning management system (LMS).

Step 3

Commence the Menzies Institute of Technology OBA Stage 1: 4 weeks online theoretical course for MCQ exam

The LMS platform will server as the primary platform for this course. The MCQ test preparation program is structured as a self-paced, fixed duration course and provide flexibility for learners to participate at their own pace. There will be online support provided by an Australian Registered Nurse educator for 6 hours per week to engage in Q&A discussions, tutoring, weekly assignments and building knowledge about Nursing in Australia.

Step 4

Attend and pass the MCQ Exam (NCLEX)

Conducted at specialised test centres, the Multiple-Choice Question (MCQ) examination is computer-based. For Registered Nurses, the National Council Lincensure Examination (NCLEX-RN) is required with a registration fee of USD 200*. An additional international schedule fee of USD 150* is applicable. The NCLEX-RN is administered through Pearson VUE test centres by the National Council State Boards of Nursing (NCSBN).

Midwives will sit an MCQ exam managed by the NMBA, which will be delivered through Aspeq test centres in most countries. For midwives, the fee is NZD 65*, plus a possible fee for overseas venues.



Step 5

Apply for visa to Australia to attend Menzies Institute of Technology Stage 2: 4 weeks face-to-face practical preparation course for Objective Structured Clinical Examination (OSCE) exam

Once you have passed NCLEX exam, then you will be able to apply for visa to Australia to attend our 4 weeks program and then attend the OSCE exam. You would need to book and confirm your OSCE exam date with the visa application.

Step 6

Arrive in Melbourne, Australia and commence the Menzies Institute of Technology Stage 2: 4 weeks face-to-face practical preparation course for Objective Structured Clinical Examination (OSCE) exam

The Objective Structured Clinical Exam (OSCE) is a clinical exam to assess your knowledge and skills and competence at the graduate level nurse. The Menzies program offers 24 hours per week for 4 weeks of practical preparation at Menzies Institute School of Nursing Healthcare Simulation Centre to adequately prepare for the OSCE exam. This course also provides a hands-on opportunity to practice and learn techniques and skills aligned with Australian guidelines. Upon course conclusion, participants will receive a Certificate of Completion recognising their successful fulfillment of the program requirements.

Step 7

Attend and pass the OSCE Exam

The responsibility for attending the examination in Adelaide, including associated costs, lies with the candidate. The examination takes place at the Adelaide Health Simulation Centre. The OSCE typically involves a series of stations where candidates rotate to complete different tasks. These tasks may include patient assessments, communication scenarios, and practical demonstrations of clinical skills. The fee for sitting the OSCE is AUD 4000*.

The OSCE is made up of 10 stations, and each station lasts for a total of 10 minutes, including 2 minutes for reading and 8 minutes for performance. Candidates are instructed not to arrive more than 30 minutes before their registration opens. Upon completing all 10 stations, candidates are required to leave their equipment outside the station and attend a post-examination briefing. Subsequently, they will be escorted from the building by the AHPRA invigilator



Step 8

Apply for Registered Nurse registration with NMBA/AHPRA

Once you have successfully passed the OSCE exam, then you are eligible to apply for Registered Nurse registration with NMBA/AHPRA. Please note there would be fees involved for application to be paid to NMBA

Step 9

Attend 2 weeks internship at an Australian Health Care Facility arranged by Menzies Institute of Technology

This will be an unpaid internship for 40 hours per week (total 80 hours) at an Australian Health Care facility. This is an invaluable opportunity to kick start your career as a Registered Nurse in Australia.

ADMISSION REQUIREMENTS, FEES AND COMMENCEMENT DATES

- 1. Applicants must provide evidence of an approval letter from the Australian Health Practitioner Regulation Agency (AHPRA) indicating which stream of entry.
- 2. Applicants must provide evidence of English language proficiency as specified by the Nursing and Midwifery Board of Australia. https://www.nursingmidwiferyboard.gov.au/Registration-Standards/English-language-skills.aspx
- 3. Applicants must provide evidenceof the following Vaccination and Immunisation: Hepatitis B, Pertussis, Diphtheria, Tetanus, Measles, Mumps, Rubella, Annual Influenza vaccination, Mantoux and clear X ray for Tuberculosis 2 weeks prior to commencement of the Internship.
- 4. Monthly Intake Dates are available for Stage 1 Menzies OBA MCQ Preparation course.

Weekly commencement date for Stage 2 Menzies OBA OSCE course depending on visa approval and arrival date of student.





Program Fees

Menzies OBA MCQ Preparation Course (4 weeks, 24 hours supervised, self-paced)

Menzies OBA OSCE Preparation course (4 weeks, 24 hours per week, 96 hours total supervised)

Menzies Post Registration Internship program (2 weeks, 80 hours total, internships facility is arranged and managed by Menzies and supervised by a Registered Nurse facilitator \$9,500 (tuition fee, material fees, placement allocation fee)
\$500 (enrolment fee – non refundable)

Initial Deposit required to confirm enrolment: \$5000 Remaining \$5,000 to be paid after completing and passing the MCQ Exam.
